Lights have been left on in the rink hut. A/CAO Tiller to do a simple sigh asking that they be turned off. Special "self-extinguishing" bulbs will be purchased for the hut also. Outdoor exercise equipment for adults will be investigated by Cllr White.

d. EMO

e. Fire Department

The FD had been in the process of looking at a new rescue vehicle. Unfortunately it was sold before they could make any inroads.

f. Newsletter

Cllr Siebrands wanted to officially thank Christine Jackson for her excellent work on the Newsletter. Many rave reviews on new format. A/CAO Tiller advised that the post office's official requirement is now 255 copies. The newsletter is now on the website.

g. Planning
