1. Call to Order:

Mayor White called the meeting to order at 7:00 pm

2. Acknowledgement

See attached. Additional information regarding the CCBF. The program has been approved for another 10 years. We have not received the paperwork yet. We will have to allocate a total of \$500K by mid October which is the fall intake deadline. Ideas for projects were suggested such as Museum, Summer Dairy Bar, Pump-track or Skateboard Park. Councillors are asked to think of ideas and let Deputy-Mayor MacKay know. Cllr Chapman advised she is available to help with the application process if required.

The Fisherman's Memorial which was started several years ago by Cllr Carol White is finally coming to completion. The sculpture is done, and the plaque is ready. It is an 11" x 17" faux brass piece with the winning poem submission. We will need to get a pedestal for it as it won't fit on the sculpture. The Murray Harbour school bell is at Lambs Concrete waiting for a pedestal to be made for it. Talk of an unveiling of the memorial along with the "something that will replace the lobster trap tree" during the Christmas in the Villages December 6 & 7 was mentioned.

Fundraising - Councillor White - Chair

The End of Summer event was not as successful as previous years due to several issues such as weather and Murray River moving the Northumberland Festival to the same weekend. The next event is the 70 Mile Yard Sale.

The Fundraising Committee is in dire need of new volunteers. At this point it is Cllr Paul White and Faye Wedlake. A lot of people show up to help at each event for which we are very grateful, however we need committee members to help with the planning, shopping etc. An ad will be placed in the next newsletter. We also need to have more people with Safe Food Handling as currently only Gordon Ramsli has it. There is also a volunteer version that is available at no cost. Once Anne has the dates, she will let council know and put an ad on the electronic sign.

11. New Business

a. Nellie's Landing - Deputy Mayor MacKay

There have been complaints made to a few councillors about noise, garbage and cars parking on people's private property. Included in council's meeting package was a copy of Nellie's Landing email to council regarding a request for council's support in applying for a liquor license. In that email council did not get the impression that Nellie's Landing would be an "everyday" local bar, but an on occasion having an event type of location. When Cal from Nellie's Landing addressed council regarding the concerns he said at his initial meeting he told council it was going to be a bar. Cal has spent a lot of money on the space. His liquor license allows him to run from 9:00 am to 2:00 am, however, he usually runs from 1:00 pm to 9:00 pm and turns the music down at 9:00 pm. Cal intends to shut down for the season on October 15th and his license expires October 31, 2024. Council will need to look into getting better information for next year as far as hours and events.

b. Belfast Annexation Plans- Anne Harnesk

The CAO from Belfast reached out regarding their annexation plans, however, I recently saw in the Graphic their Amalgamation Committee has been disbanded and this issue has gone back to their council as there was a lot of push back from residents of surrounding areas.

c. Storm Sewer Drain in front of Fire Hall - Mayor Terry White

Mayor White spoke to the crew fixing the storm sewer drain in front of the Fire Station. The crew told Mayor White that this is just a band-aid as the pipe below the road is rotted out from the salt water. There is also another drain in front of James Irving's house on Main Street that workers will be coming back to look at. Councillors are asked to come to the October council meeting with a list of road repair items. A letter will then be submitted to the Province in November to make them aware of these issues and hopefully allow them time to add our items to their 2025 road repair list.

Mayor White also spoke to Alec Blue of Highways and Alec said the province is looking at replacing the curbs on Main Street with concrete curbs. It was mentioned there were also a few curbs on Library Street that have been damaged by plows.

d. Purchase of Blue Tanks from Mayor Terry White - Cllr Paul White

Mayor White is selling two of his large blue tanks. We have been using these tanks at all fundraising functions where we are offering food and beverages for sale. Mayor White is offering the Village "first dibs" on the tanks. The tanks are three years old, and he paid \$1,100 each for them.

Moved by Deputy Mayor MacKay and seconded by Cllr. White that Council hereby approve the purchase of the two large blue tanks for the amount of \$700.00.

Vote was 5-0 in favour; motion carried.

12. Adjournment

Moved by Deputy Mayor MacKay and seconded by Cllr Robertson to adjourn at 8:45 pm.
